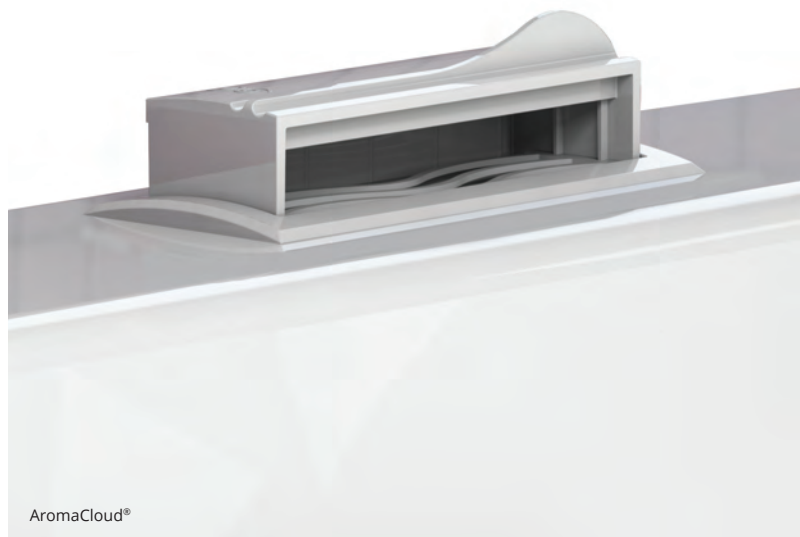

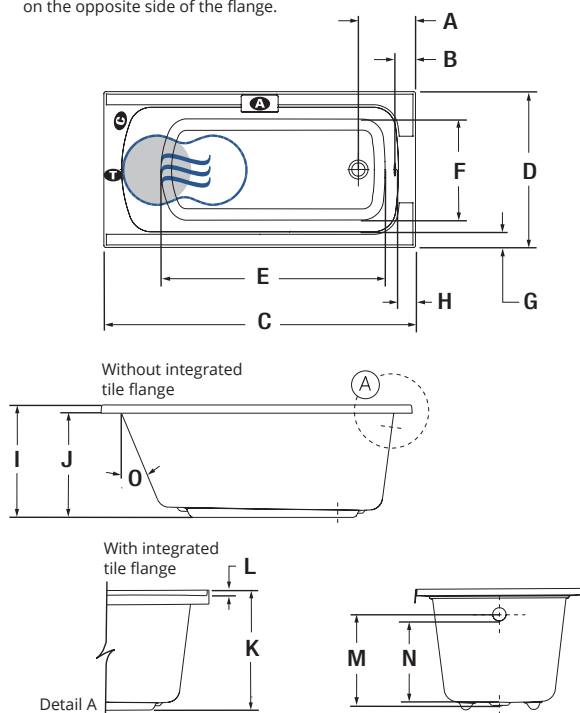

Hot water supply required	The hot water supply should be 70% or more of the bath's total water capacity.
Turbine	Access to the pump must be at least 18" x 22". Standard connection is 20 A, 120 V, 60 Hz , dedicated line with a Ground-Fault Circuit Interrupter (GFCI). For any additional option, a second line is needed 15 A, 120 V, 60 Hz , dedicated line with a GFCI. Air vent necessary: 2" x 4" minimum.

It must be connected to the hot water supply and be accessible (provide access). There is a height difference for the integrated tile flange (see Detail A). Available with or without integrated tile flange (specify right or left) at the same price.
