All wiring must comply with applicable local and national codes.
- a. Power Supply Wiring to Outdoor Unit (No. x AWG): 3 x 12 for 18k and 24k; 3 x 10 for 30k, 36k, 42k, 48k, and 60k.
- b. Power Supply Wiring to the third-party Furnace is to be specified by the manufacturer.
- c. Control Cable between the Outdoor Unit and the third-party Furnace (No. x AWG): 6 x 18.
- d. The 24V Control Power to the A-Coil is to be sourced from the third-party Furnace.
- e. The Control Cable between the third-party Furnace and the thermostat (No. x AWG): 6 x 18.
6. Nominal data is rated 0 ft. above sea level, with 25 ft. of refrigerant line and a 0 ft. level difference between outdoor and indoor units.
7. Must follow installation instructions in the applicable LG installation manual.


